CIARDELLI FUEL CO. – TERMS OF SERVICE

EQUIPMENT: TITLE & ACCESS

Propane tanks, meters & regulators utilized by our customers are the property of Ciardelli Fuel Co. Additional equipment employed for storing, distributing, regulating & metering of fuel may also be identified as the property of Ciardelli Fuel Co. The applicant hereby grants to Ciardelli Fuel Co. the right to enter upon their property for the purpose of installation, maintenance, repair, replacement and removal of Ciardelli Fuel Co. equipment. Upon termination of this service, a restocking fee may apply to a customer's residual propane should Ciardelli Fuel Co. have to return to remove our tanks.

Fuel Oil, Kerosene, and Diesel storage tanks are the property of the customer.
Ciardelli Fuel Co. assumes no liability or maintenance responsibility of these types of tanks.

TERMS OF CREDIT

Accounts unpaid 30 days after billing are considered past due which may result in suspension of deliveries and service until the account is made current. Budget accounts are considered past due if a payment is missed. A past due budget account may lose budget privileges and may revert to special approval credit terms.

Accounts for rental units must have the property owner's written guarantee or will require a cash deposit from the tenant prior to any delivery of service. A tenant customer's credit limit will be equal to their deposit, and their deposit may be held in escrow at the discretion of the Ciardelli Fuel Co. The customer bears the responsibility to pay their bills within terms. There will be no notification of termination of service or delivery of fuel for past due accounts. In instances where unscheduled trips to deliver or provide service are necessary due to failure to meet credit terms, an additional charge may be levied to cover associated costs.

FINANCE CHARGE ON PAST DUE ACCOUNTS

Balances which remain unpaid 30 days after billing are subject to a finance charge of 1.5% per month (Annual Percentage Rate = 18%). In the event their account goes into collection, the undersigned applicant agrees to be responsible for all costs related to collection including, but not limited to, attorney's fees, court costs, and service of notice fees. Additionally, a \$25.00 collection service fee will be added to the account balance at the time the account is placed into collection. Any additional fees incurred as a result of placement with a collections agent will also be the obligation of the account holder.

The undersigned applicant understands and agrees with these terms of service set forth herein and acknowledges receipt of a copy of this document. The information the undersigned applicant has given is for the purpose of obtaining credit and is warranted to be true. The undersigned applicant hereby authorizes Ciardelli Fuel Co. to verify any references provided pertaining to their credit and financial worthiness. During the term of this contract, if the undersigned applicant alters their heat source (thereby changing their fuel consumption) they must notify Ciardelli Fuel Co. or the automatic delivery feature will no longer apply. All deliveries are made on an automatic schedule which is established by Ciardelli Fuel Co.
